2017 SUMMER CAMP SESSIONS

Sauganash Montessori School is offering three, 3-week summer options for children ages 3-6 from June 12th through August 11th. Enrollment is open to all children (until 5/1/17 or session is full.) You may choose any or all sessions. **The classroom is prepared with traditional Montessori materials and is enriched with the theme unit activities. There will be maximum outdoor/park time, projects, and picnics.** The sessions will be taught by current teachers who will maintain the high standards of Montessori theory and practice. We promise lots of fun, lots of sun (and sunscreen) and an educational summer your children will love. All materials are included. Session I (June 12th – June 30th) Theme: “I Love Art” led by Miss Bridget

3.) Failure to abide by the TERMS OF PAYMENT policy will represent a breach of the tuition contract. In the event of a default payment, I/we agree to pay all collection costs and expenses, including attorney fees and all other fees incurred by SMS in collecting any amount due.

BASIC TERMS

1.) I/We understand that students are admitted to the Sauganash Montessori School for the summer sessions selected above and that my agreement to pay the total tuition due is not subject to adjustment because of illness or absence. Should withdrawal be necessary, I must give written notification to the Executive Director at least 30 days prior to withdrawal in order for a tuition adjustment consideration.

2.) The decision to offer contracts is made annually regardless of the previous year's enrollment. SMS reserves the right, in its sole discretion, to deny any student re-enrollment in SMS.

3.) I/We hereby give permission for the student to participate in daily visits to Sauganash Park, walks in the neighborhood and school sponsored field trips.

4.) I/We understand that our family health plan provides coverage for any accidental injuries my child may incur during school hours or school sponsored activities. In case of an emergency and if necessary, SMS has the right to contact the child's physician and/or take the child to the nearest hospital at our expense.

5.) SMS reserves the right at all times and in its sole discretion to dismiss the student for any reason, including but not limited to, non-payment of tuition.

RELEASE AND WAIVER OF CLAIMS

I/We agree to release SMS and its directors, officers, employees and agents from all claims, causes of action, damages, liabilities, and losses arising out of or resulting from the student's participation in SMS programs, to the extent permitted by law, except for acts or omissions involving willful or wanton conduct by a director, officer, employee or agent of SMS.
